In America, we value Freedom, Justice, and Equality and we all deserve the protection granted by the Presumption of Innocence. All complacent government officials must be held accountable for their choice to indefinitely incarcerate hundreds of men and women without Due Process. We must stand up for the rights of others if we are to protect our own.

Most Americans accused of a crime are presumed innocent until proven guilty. The government has the burden of proving every element of every offense beyond a reasonable doubt, before anyone is punished for an alleged crime.<sup>2</sup> However, Governor Tim Walz maintains a state government that indefinitely incarcerates men and women based on what they might do. This is called preventive detention and it allows a person to be locked up, until they are dead, without first convicting them of a crime. The system is the Minnesota Sex Offender Program (MSOP) and maintains two maximum security facilities in Minnesota—one in Moose Lake and one in St. Peter. The name of the institution is intentionally misleading to the public. An "offender" is someone who has been convicted of a crime of a sexual nature. However, as judge R.A. Randall put it, "...there is no crime involved..." 12% of the population at these facilities have clean records. For those who do have criminal records, the individuals have done their time in prison and have the lowest rate of same-crime recidivism than any other category of offender.<sup>5</sup> They are now being housed for life after they served their time in prison.

Anyone can get indefinitely detained in Minnesota without committing a crime. In Minnesota, the "clear and convincing" standard is used to "civilly commit" men and women. The tests used to determine who gets committed are "...inherently faulty... subjective and unreliable." Now hundreds of men and women are being held unconstitutionally. A person being considered for "commitment" does not have a right to a jury trial. It is not necessary to prove that the person lacks self-control, or that they are physically violent. As little as two allegations of sexual harassment is enough and hearsay is admissible. Minnesota judges will even indefinitely detain someone based on alleged conduct displayed as a child. For example, September 2020 marked Dan Larsen's 43rd year incarcerated. He was 15 years old when the Governor locked him up. Larsen has no criminal record. He remains confined today. There are so many others like him that must be released and returned to their families.

Sensationalized media coverage of a tragic but incredibly rare case in 1994 motivated the laws of preventive detention in Minnesota. Overwhelmed by moral panic, it took only 93 minutes for lawmakers to pass a law that completely ignores our U.S. Constitution. Similar systems previously existed in this country. Thousands of Japanese-Americans were incarcerated after the attack on Pearl Harbor. Americans were even warned by the Highest Court when Justice Antonin Scalia said, "You are kidding yourself if you think the same thing will not happen again..." Justice Scalia's prediction has become a reality in the state of Minnesota. The result is a state empowered to imprison citizens prospectively for what they *might* do in the future.

In addition to the forgoing, the system is a massive waste of taxpayer money. The men and women detained are billed for their indeterminate confinement and the taxpayers pay the bill. At \$143,445 a year, housing one person in preventive detention costs taxpayers three times the cost of a prison inmate. There is currently 743 men and women detained in Minnesota. This amounts to more than \$106 million a year that taxpayers are responsible for.

The current conditions are ripe for mass incarceration. If you allow a *de facto* Constitution free zone for others, the same exceptional approach can be applied to anyone. join us at the OCEAN Community Conference and Rally and stand in solidarity while we demand the abolishment of preventive detention in Minnesota.

For every 1 million people that live in Minnesota, 131 of them are being held in preventive detention until they are dead. Minnesota "commits" more men and women per capita than any other state.

The same year that Minnesota cut its funding for sexual violence prevention programs by \$3.6 million per year, it spent \$26 million of taxpayer money to detain 235 people to preventive detention facilities,<sup>2</sup> even though preventive detention does nothing to lower crime rates.<sup>3</sup>

Taxpayers are currently paying over 800 individuals to operate a preventive detention scheme in Minnesota. The 4 highest paid individuals at these facilities are, Mustafa Kendi, Lauren Herbert, Nancy Johnston, and Jannine Hebert. Together they make over \$800,000 a year. Mustafa Kendi is the highest paid individual and makes over \$346,000 annually.

Sullivan fled from Minnesota to Britain amid criminal charges.

Russell Hatton, who has been detained for over 15 years, has been billed over \$1.5 million by the institution. Once he is dead, the state can confiscate whatever property he owned to pay the debt, leaving nothing for his children.

In 1998, the American Psychiatric Association took the position that Minnesota's application of "civil commitment" is, "...an unacceptable misuse of psychiatry."

The Deputy Director of Minnesota's preventive detention scheme, James Berg, admitted that the "program" cannot be completed. Almost 90 men have died trying anyway.

Although civil commitment is only legal *if* there is a "...medical justification..." officials of the so-called, "civil commitment" system in Minnesota blatantly admit and the vast majority of the people confined are not mentally ill. Even the Clinical Director of the scheme, Jannine Hebert, confessed, "...we made a conscious decision to move away from that medical model approach..." This is illegal.

We must stand for the rights of others if we are to protect our own. The people warehoused are not mentally ill and the place is not a "treatment center." It is preventive detention plain and simple and it must be abolished.

# The Schedule for July 18, 2021
